### IMPROPER USE OF LEDGLOW TRADEMARKS

The following are examples of uses of the LEDGlow Trademarks that dilute our trademark rights, are harmful to LEDGlow’s goodwill and likely to cause confusion in the marketplace:

1. Combining a LEDGlow Trademark with any other words to create a new word, slogan or web address (e.g. LEDGlow Factory Outlet).
2. Altering any LEDGlow Trademark or any design comprising the LEDGlow Trademark, including, without limitation:
  - i. Use of LEDGlow logo without the armature or with the armature positioned incorrectly
  - ii. Use of LEDGlow logo in a modified state other than the registered trademark version
  - iii. Use of LEDGlow logo in a sentence or positioned next to copy
  - iv. Use of LEDGlow logo without “silent space” around it
  - v. Positioning LEDGlow logo graphically so that it abuts or runs into another logo or copy
3. Use of the LEDGlow Trademarks in a website in such a manner that leads visitors to believe that the website is owned, operated by, sponsored or otherwise associated with LEDGlow.
4. Use of the LEDGlow Trademarks as part of a domain name or URL
5. Use of the LEDGlow Trademarks to advertise the reseller or distributor as a preferred or official outlet, reseller or distributor, including use in paid search ads and banner display ads, without prior written consent.

LEDGlow reserves all rights within the law to terminate the privileges of its trademark use, in the event of improper or unauthorized infractions of this trademark policy.
